The document is written in cursive italic type to the right, in ink. The document contains three mixed deeds in verso and recto pages, which grant rent of goods and refer to male and female slaves' sales. The records are presented as minutes, mentioning the city of Lima, year 1832, and the participation of the scribes Baltazar Nuñez del Prado and Juan Cosío.

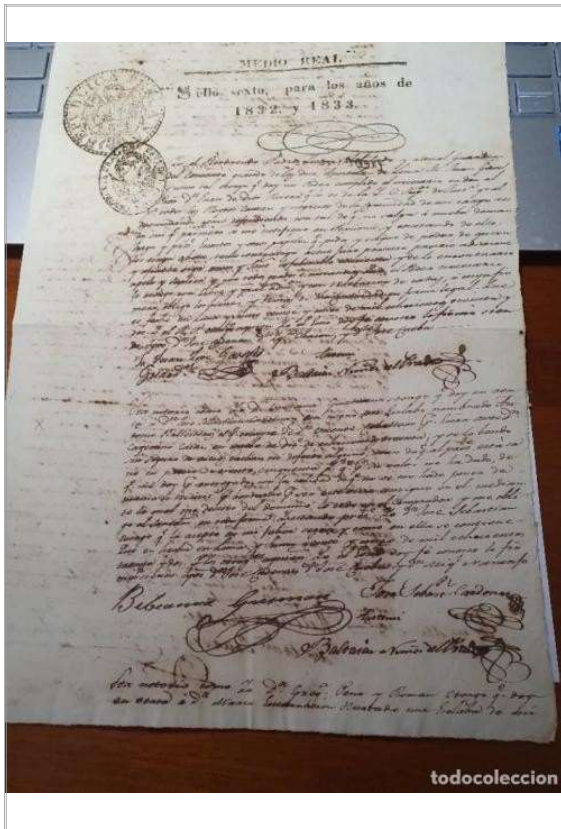


Image: Front View

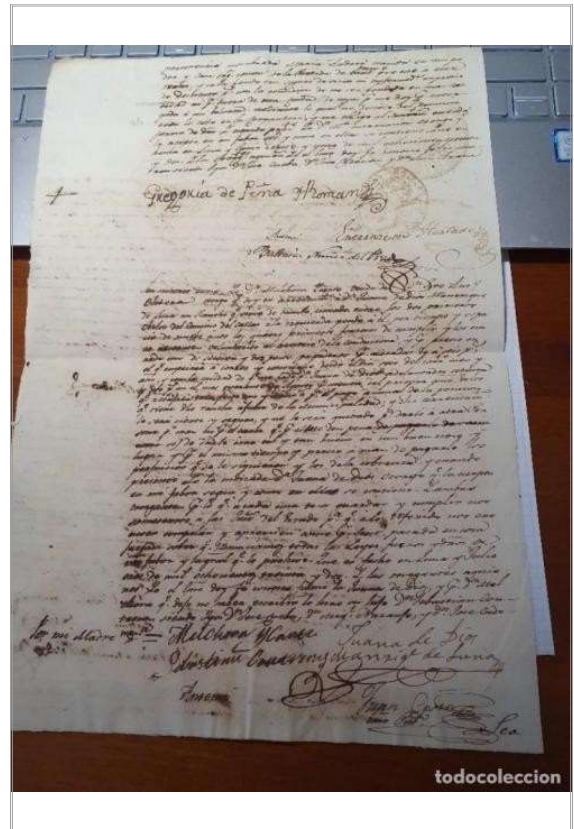


Image: Rear View

The document is written in cursive italic type to the right, in ink. The document contains four deeds (the last one incomplete) in verso and recto pages, about sales of slaves with their respective clauses, carried out in the months of July and August 1832; also, the intervention of Juan Cosio as an intermediary of the purchase on behalf of his daughters, and with the participation of witnesses.

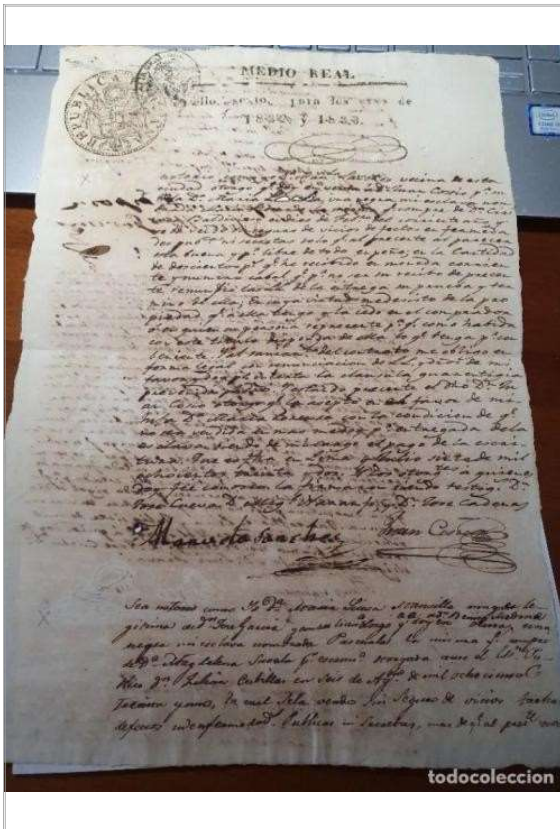


Image: Front View

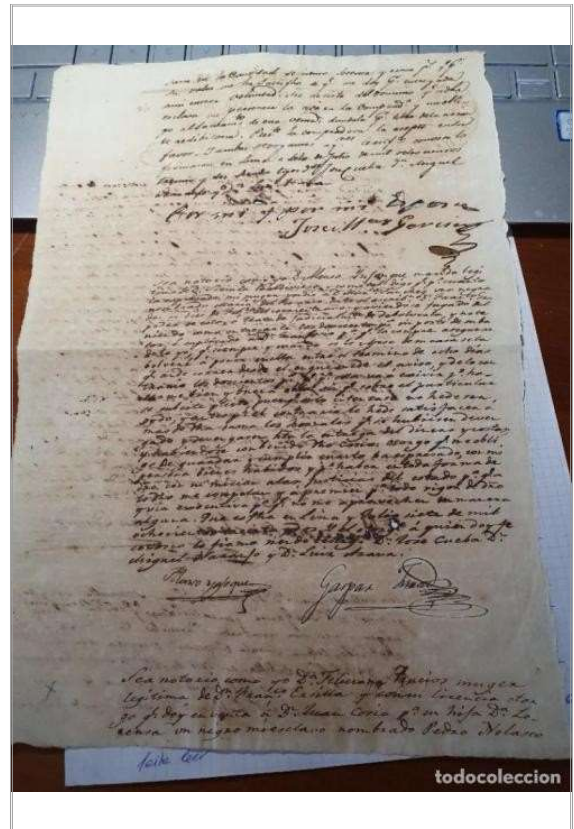


Image: Rear View

The document is written in cursive italic type to the right, in ink. The document contains the continuation of the fourth deed of the previous document, four deeds on the sale of slaves with their respective clauses, and other records granting power of attorney. The four deeds are made on 13, 14, 17 and 20 June, respectively, and correspond to the year 1832. One of the records is signed by the notary Juan Cosio, and the other three by Gaspar Jurado. Also, the records mention other scribes, such as Luis Salazar.

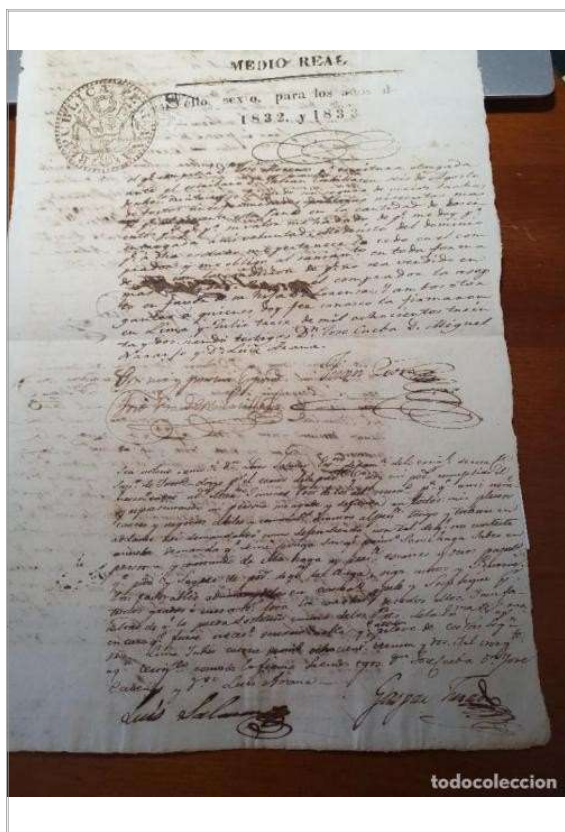


Image: Front View

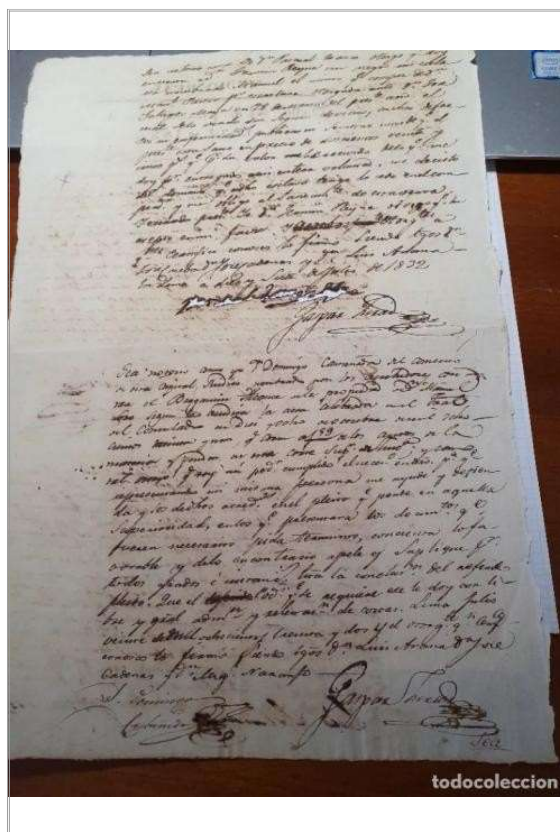


Image: Rear View

The document contains a first record with data "No Corrió" (invalid record), and four deeds, in verso and recto pages, about sales of slave with their respective clauses. The four deeds date from 20 and 22 June 1832, three of which are signed by the scribe Baltazar Nuñez del Prado.

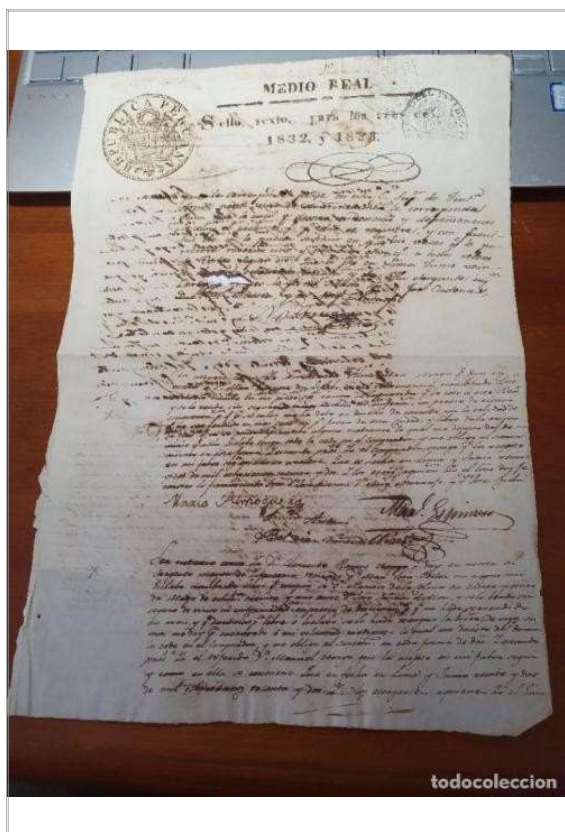


Image: Front View

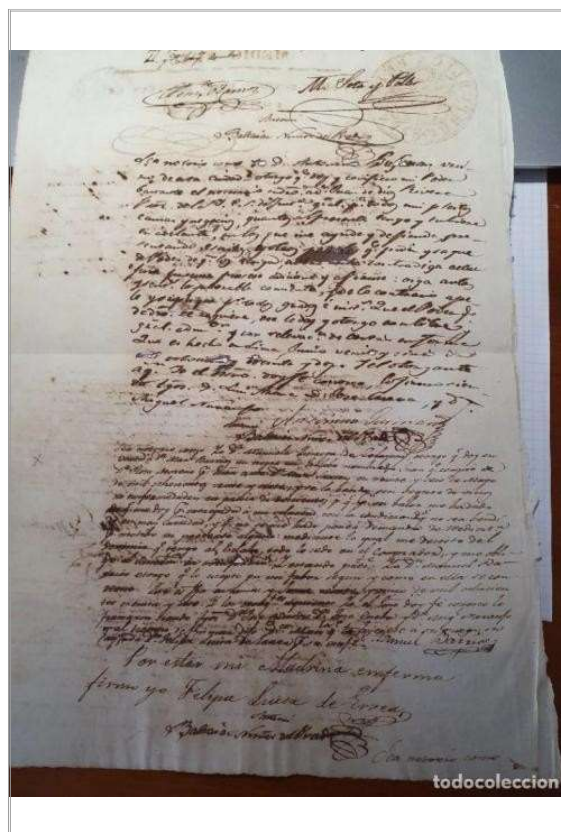


Image: Rear View

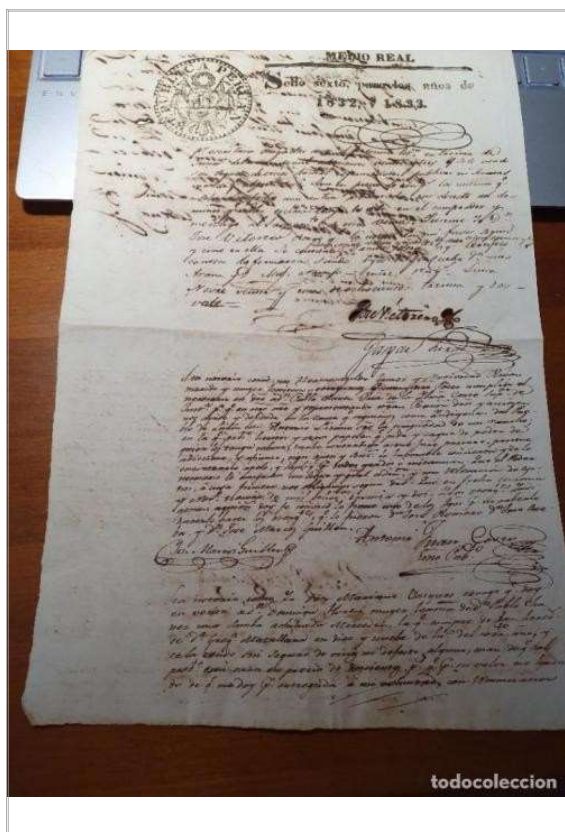


Image: Front View

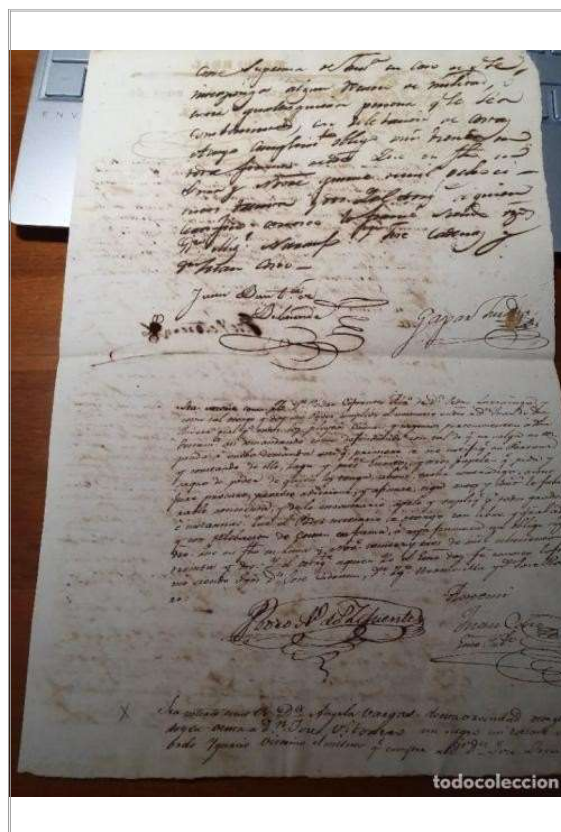


Image: Rear View

Two-page document in Stamped-Impressed Paper, with a circular stamp of the "REPÚBLICA PERUANA" ("REPUBLIC OF PERU") and an illegible oval seal, inscriptions: "MEDIO REAL" ("HALF REAL"), "Sello sexto (Sixth Seal), for the years 1832 and 1833". The document is written in cursive italic type to the right, in ink. The document contains, in verso and recto pages, deeds on the granting of power of attorney and two last wills that refer to the transfer of goods, including (those of) a slave, also asking for the freedom of a female slave upon her death. The other last will refers to the distribution of assets after his death. Two of these records have the signature of Gaspar Jurado.

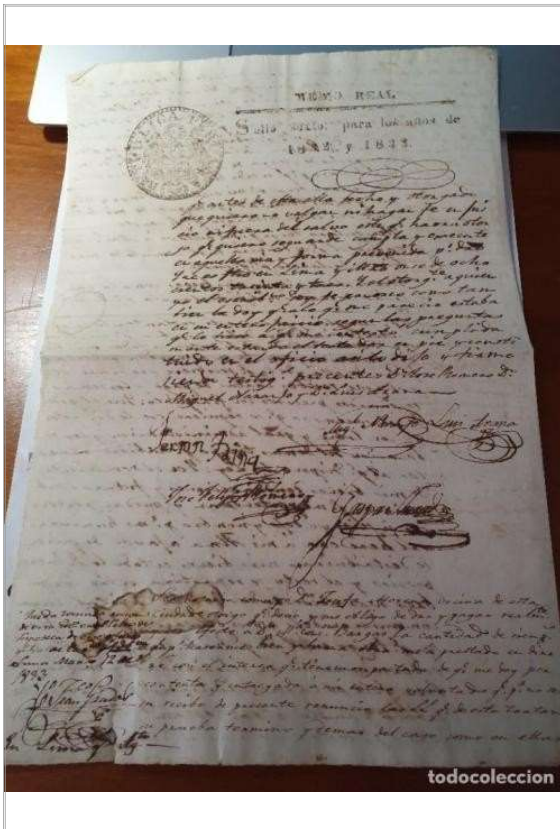


Image: Page 1, front view

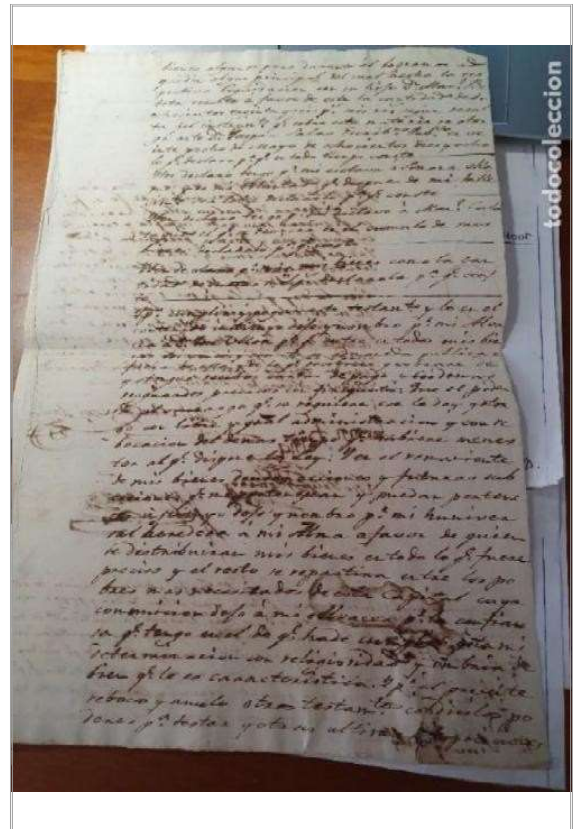


Image: Page 1, rear view

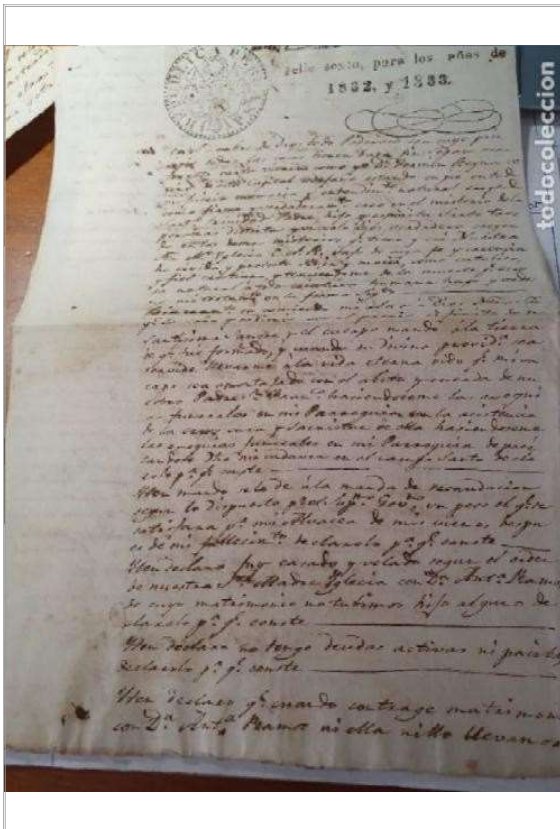


Image: Page 2, front view

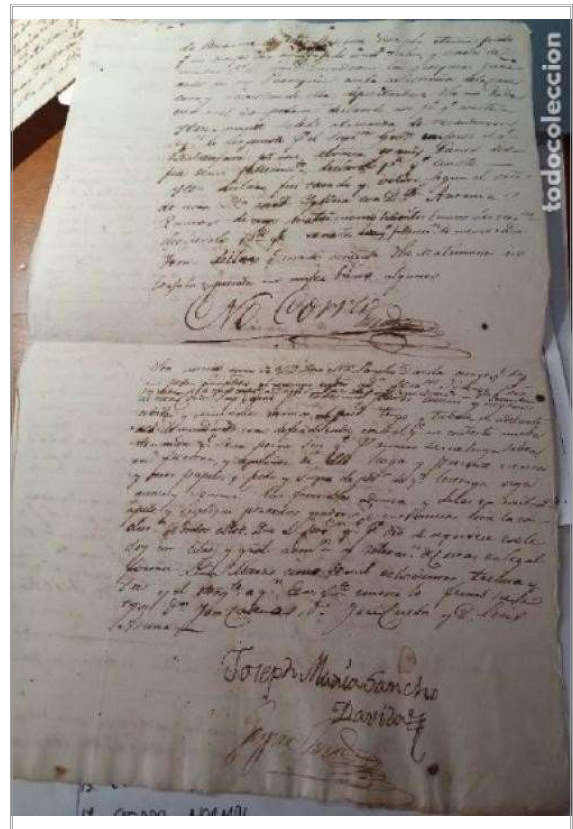


Image: Page 1, rear view
